# ARTICLES OF INCORPORATION OF CENTRAL FLORIDA GRADING, INC.

THE UNDERSIGNED, acting as the Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### **ARTICLE I**

The name of this corporation is CENTRAL FLORIDA GRADING, I

#### **ARTICLE II**

The period of its duration is perpetual.
