**ARTICLE I

DURATION**

The corporation shall have a perpetual existence.

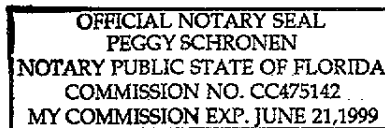
