Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation.

This is to certify that at a meeting of the stockholders and directors of DELTA SEVEN INC, a Florida Corporation, held at 4557 Beach Dr SE, St. Petersburg, FL, on August 8, 1999, the following resolution was approved by the Board of Directors and ratified by the stockholders of the corporation.
