ARTICLE I - NAME

The name of the corporation is STRAND & SON CLEANING, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually commencing on the date of execution and acknowledgement of these Articles.

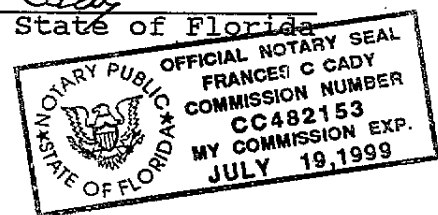

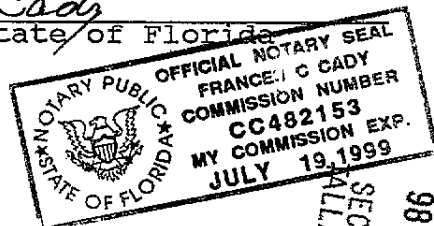
