ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is SUITABLE RE-EMPLOYMENT SERVICES, INC., and the principal address and principal place of business is 1700 McMullen Booth Road, Suite D-4, Clearwater, Florida 33759

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is c/o PATEL, MOORE & O'CONNOR, P.A., 2240 Belleair Road, Suite 160, in the City of Clearwater, County of Pinellas, Florida 33764. The name of its registered agent at such address is Steven W. Moore.

ARTICLE III - PURPOSE
