**ARTICLES OF INCORPORATION

The undersigned incorporators, for the purpose of forming corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation, effective upon receipt by the Florida Department of State.

ARTICLE I. CORPORATE NAME

The name of this corporation is **Kreider and Ramey, Inc.** The period of its duration is perpetual and is effective upon receipt by the Florida Department of State.

ARTICLE II. PRINCIPLE OFFICE

The principle place of business and mailing address of this corporation is 5211 S. W. 91st Terrace, Suite B, Gainesville, Florida 32608. The bylaws may provide for relocation of the principle office or mailing address to any other address.

ARTICLE III. CORPORATE PURPOSE

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States and Florida.

ARTICLE IV. CAPITAL STOCK

The corporation is authorized to issue 200 shares, all of one class, at \$1.00 par value. Said stock shall be non-assessable and shall be payable in lawful money of the United States or in other property (other than stock or securities), at a just valuation to be fixed by the board of directors of this corporation

ARTICLE V. INCORPORATORS

ARTICLE VI. INITIAL REGISTERED AGENT AND OFFICE

The name and address of the initial registered agent is Consuelo Kreider, 5211 S. W. 91st Terrace, Suite B, Gainesville, FL 32608.

ARTICLE VII. INITIAL BOARD OF DIRECTORS

The business of this corporation shall be conducted, carried on, and managed by the officers of this corporation and a board of directors composed of one or more members, which number may be altered from time to time in accordance with the bylaws adopted by this corporation within the limits prescribed by law. The names and street addresses of each member of the first board of directors is:

They shall hold office until the first annual meeting of stockholders. The officers of this corporation shall be a president and any other officer as the board of directors may deem expedient. A member of the board of directors may be an officer of the corporation. Any two or more offices may be held by the same person. If all the directors severally or collectively consent in writing to any action taken or to be taken by the corporation, and the writings evidence their consent are filed with the Secretary of the corporation, the action shall be valid as though it had been authorized by the board of directors.

ARTICLE VIII. AMENDMENTS TO THE ARTICLES

This corporation reserves the right to amend or repeal any provisions contained in the Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation. The power to adopt, alter, amend, or repeal the Articles of Incorporation or its bylaws of this corporation shall be vested in the shareholders by fifty-one (51) percent vote.

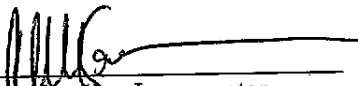
ARTICLE IX. ELECTION OF DIRECTORS

At all elections of directors of this corporation, each shareholder shall be entitled to as many votes as shall equal the number of votes which (except for these provisions as to cumulative voting) the shareholder would be entitled to cast for the election of directors with respect to his shares of stock, multiplied by the number of directors to be elected. The shareholder may cast all such votes for a single director or may distribute them among the number to be voted for, or any two or more of them, as the shareholder may see fit.

ARTICLE X. SHAREHOLDER RIGHTS

Each shareholder of this corporation shall have the first right to purchase shares (and securities convertible to shares) of any class, kind or series of stock in this corporation that may from time to time be issued (whether or not presently authorized), including shares from the treasury of this corporation, in the ratio that the number of shares outstanding, exclusive of treasury shares. This right shall be deemed waived by any shareholder who does not exercise it and pay for the shares pre-empted within thirty (30) days of receipt of a notice in writing from the corporation, stating the prices, terms and conditions of the issue of shares, and inviting him to exercise his pre-emptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice of the corporation.

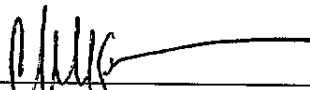
Designation and Acceptance of Registered Agent for a Florida Corporation
