The undersigned subscribers to these articles of incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is DONALD M. IHRIG ASSOCIATES, INC.

ARTICLE II. NATURE OF BUSINESS

The general nature of the business is all phases of the construction and office business and all businesses permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 500 shares of common stock. The consideration to be paid for each share shall be fixed by the Board of Directors. The initial par value shall be \$1.00 per share.

ARTICLE XI. AMENDMENT

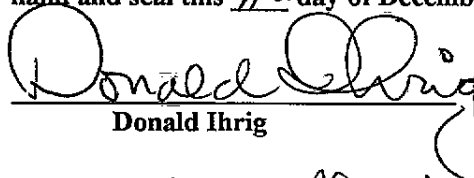
