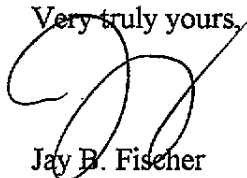

NAME

The name of this corporation is D & S OF KEY WEST, INC.

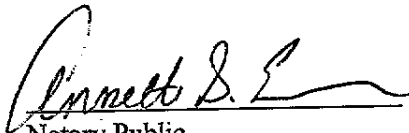

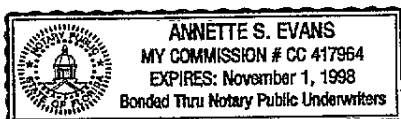
