ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF FAR EAST TROPICAL NURSERY COMPANY

Pursuant to the provisions of Sections 617.1001 et seq. of the Florida Stătutes undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is: FAR EAST TROPICAL NURSERY COMPANY, INC.
- 2. The following amendment to the Articles of Incorporation was adopted by the Board of Directors of the corporation on February 3, 1998 in the manner prescribed by the Florida Business Corporation Act:
