OF

**ARTICLE I.
NAME**

The name of the corporation is: EARTH RANGERS, INC.

**ARTICLE II.
PRINCIPAL OFFICE**

The principal office of the Corporation (or the mailing address) will be: 3508 Broken Woods Drive, Coral Springs, Florida 33065.

**ARTICLE III.
DURATION**

The corporation shall exist in perpetuity.

**ARTICLE IV.
PURPOSE**

The corporation is organized for the purposes of transacting any and all lawful business.


