ARTICLE I.

<u>NAME</u>

The name of this corporation shall be PCM Investment Group, Inc., and it is hereinafter referred to as the "Corporation".

ARTICLE II.

PURPOSES, OBJECTS AND POWERS _

The effective date of existence for the Corporation shall be January 5, 1998.
