The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

**FIRST:** The corporate name for the corporation (hereinafter called the "Corporation") is **DIAGNOSTIC RADIOLOGY NETWORK OF FLORIDA, INC.**

**SECOND:** The street address, wherever located, of the principal office of the Corporation is 4800 NW Second Avenue, Suite 6, Boca Raton, Florida 33431.

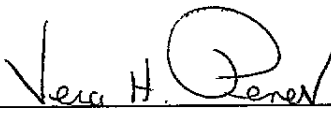

**SIXTH:** The purpose for which the Corporation is organized is to engage in all lawful business activities for which a corporation may be organized under the Florida Business Corporation Act.

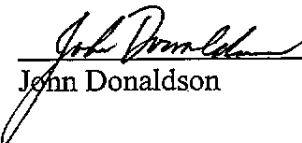
**SEVENTH:** The duration of the Corporation shall be perpetual.
