The Articles of Incorporation are hereby amended by deleting Article III, entitled "Capital Stock", in its entirety, and replacing it with the following new Article III, entitled "Shares", so that Article III, as amended, reads as follows:

Article III, Shares: The total number of shares that the Corporation is authorized to issue and have outstanding at any time is eleven million (11,000,000) shares, of which (i) five million (5,000,000) shares shall be designated as Class A Common Stock with one (1) vote per share; (ii) one million (1,000,000) shares shall be designated as Class B Common Stock with ten (10) votes per share; and (iii) five million (5,000,000) shares shall be designated as preferred shares, with the preferences, limitations and relative rights determined by the Corporation's Board of Directors. All shares shall have no par value.
