**ARTICLES OF INCORPORATION  
OF  
CEW PRODUCTS, INC.**

**THE UNDERSIGNED**, acting as sole incorporator of **CEW Products, Inc.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I  
NAME**

The name of the corporation is "CEW Products, Inc."

**ARTICLE II  
SHARES**
