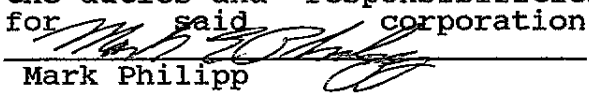
ARTICLE V

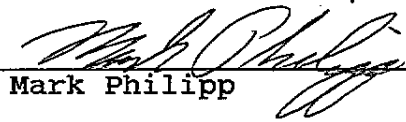

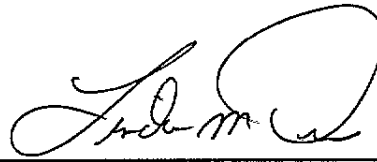
