Small Business Corporation as defined in Section 1244  
Subdivision (c) (2) of the Internal Revenue Code.

ARTICLE I. Name. The name of the corporation is

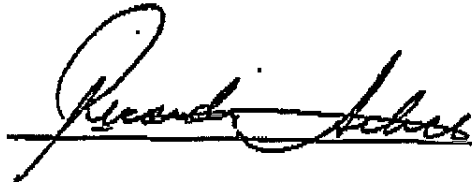
