

The undersigned does hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the state of Florida.

# ARTICLE I - NAME The name of the corporation is: GAILANNE P. WALZAK INC.

#### ARTICLE II - PURPOSE

The corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida.
