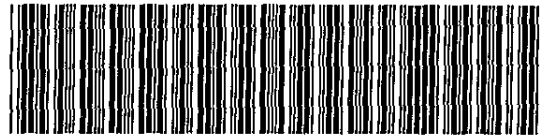

The name of the corporation to be dissolved is PARABORNE AVIATION CORP.

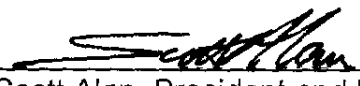
ARTICLE II DATE

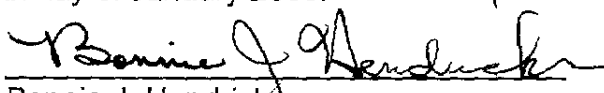
