# ARTICLES OF INCORPORATION OF Suarez Auto Repair, Inc.



#### ARTICLE I - NAME AND ADDRESS

The name and mailing address of the Corporation is Suarez Auto Repair, Inc., 1747 N.W. 23 Street, Miami, Florida 33142.

#### ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

#### ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

#### ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1,000,000 shares of common stock having a one dollar (\$1.00) par value per share.
