ARTICLES OF INCORPORATION
OF

ARTICLE I

The name of this corporation is ROY ARRON PARKER D.M.D, P.A. The principal office and/or mailing address of this corporation is as follows: 7611 - 9th Avenue N.W., Bradenton, Florida 34209.

ARTICLE II

This corporation is organized for the following purposes: To carry on the business, occupation, undertaking and enterprise of general dentistry and to exercise any power or authority which may be done by a private corporation organized and existing under and by virtue of Florida Statutes, Chapter 607 (1995) and Chapter 621 (1995), it being the intention that this professional corporation may conduct and transact only such professional service business lawfully authorized and not prohibited by Florida Statutes, Chapter 621, (1995).

ARTICLE III

This corporation is authorized to issue 100 shares of \$100.00 par value common stock, all of which shall be fully paid and non-assessable. This corporation may issue its capital stock only to a professional corporation, a professional limited liability company, or an individual who is duly licensed or otherwise legally authorized to render professional general dentistry services in the State of Florida.

ARTICLE IV

The corporation elects to have preemptive rights.

ARTICLE V

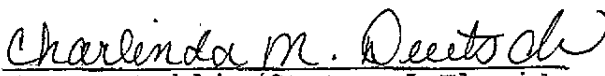


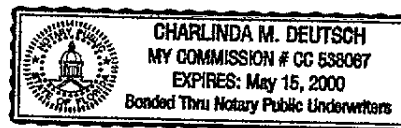
