

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF NOBLE COMMUNITIES, INC.



Pursuant to Section 607.1006, Florida Statutes, the Articles of Incorporation of NOBLE COMMUNITIES, INC. are hereby amended as follows:

FIRST: Article I of said Articles of Incorporation is amended by deleting the provisions of said Article I as the same now exists, and by substituting in lieu thereof, the following:

"ARTICLE I. NAME

The name of this Corporation shall be ARTHUR DAVIS COMMUNITIES, INC.

SECOND: The foregoing Amendment was adopted by all of the Directors and Shareholders entitled to vote, without a meeting, by Unanimous Consent in Writing, dated the 2/ day of March, 2000, which is sufficient for approval.
