ARTICLES OF INCORPORATION

OF

Concrete & Framing, Inc.

I, the undersigned subscriber of these Articles of Incorporation,
a natural person competent to contract, acting as incorporator of
a corporation under the Florida General Corporation Act, do
hereby adopt the following Articles of Incorporation for such
corporation:

ARTICLE I - Name and Address

The name and address of this Corporation is:

ARTICLE II - Duration

This Corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation.

ARTICLE III - Purpose

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - Capital Stock

This Corporation is authorized to issue ONE THOUSAND (1000) shares of ONE DOLLAR (1.00) par value common stock, which shall be designated "Common Shares".

ARTICLE VI - Preemtive Rights
