ARTICLE ONE

The name of the corporation is **ESSIAC ®INTERNATIONAL, INC.** The principal address of the corporation is: 910 S.E. 5th Terrace, Pompano Beach, Florida 33060.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.


ARTICLE EIGHT
