


BY-LAWS



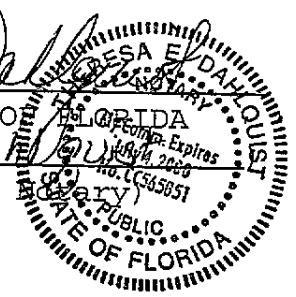
