## ARTICLES OF INCORPORATION

OF

## PBLF ENTERPRISES, INC.



The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

- 1. <u>Name and Address</u>. The name of the Corporation shall be PBLF ENTERPRISES, INC. The mailing address of the Corporation shall be 36426 U.S. Highway 19 North, Palm Harbor, FL 34684.
- 2. <u>Duration</u>. The Corporation shall have perpetual existence.
- 3. <u>Purpose</u>. The purpose of the corporation is to engage in any activities of business permitted under the laws of the United States and of Florida.
- 4. <u>Capital Stock</u>. The corporation is authorized to issue 1,000 shares of common stock, at a par value of ONE (\$1.00) DOLLAR per share.

- 8. <u>Bylaw Amendment</u>. The power to adopt, alter, amend or repeal the Bylaws of this corporation shall be vested in the Board of Directors.
- 9. <u>Indemnification</u>. The corporation shall indemnify any officer or director, or any former officer and director, to the full extent permitted by law.
