**Articles of Incorporation
of
ADVANCED COMMERCIAL TELECOMMUNICATIONS, INC.**

I, the undersigned incorporator, hereby make, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation under the laws of the State of Florida.

I.

Name

The name of the Corporation shall be: ADVANCED COMMERCIAL TELECOMMUNICATIONS, INC., hereinafter referred to as the "Corporation."

II.

Purposes

The purpose of the Corporation is organized is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

III.

Principal Office and Registered Agent

The principal office of the Corporation is 543 Beckrich Road, Panama City Beach, Florida 32407. The Corporation may maintain offices and/or transact business at other locations, either within or without the State of Florida. The name and address of the registered agent for service of process upon the Corporation is Robert M. Ecker, Jr., 543 Beckrich Road, Panama City Beach, Florida, 32407.

IV.

Duration

The duration of the Corporation shall be perpetual unless dissolved according to law.

V.

Initial Business

The general purpose for which this Corporation is organized is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

VI.

Capital Stock

The Corporation is authorized to issue only one class of shares of stock which shall be designated Common Stock. The total number of shares the Corporation shall have authority to issue is ONE THOUSAND(1,000) each share to have a par value of \$1.00 per share. The whole or any part of the authorized shares of the Corporation may be issued for a consideration payable in cash or other property, tangible or intangible, or in labor or services actually performed for the Corporation, having a value as is determined from time to time by the Board of Directors of the Corporation, not less than par value of the stock so to be issued.

Directors

The powers of the Corporation shall; be exercised by or under the authority of and the business and affairs of the Corporation shall be managed under the direction of a Board of Directors.

The number of directors constituting the initial Board of Directors of the Corporation is: Two (2). The number of directors may be increased or decreased by the shareholders from time to time. Operating Provisions

The provisions for the operation, regulations, and management of the business and internal affairs of the Corporation shall be as set forth in the Bylaws, which may be amended from time to time by a majority vote of a quorum of the Board of Directors.

XI
Special Provisions

The following additional provisions for the regulation of the business and for the conduct of the affairs of the Corporation and for creating, defining, limiting and regulation the powers of the Corporation, its shareholders and directors, are hereby adopted as a part of these Articles of Incorporation.

1.) No person shall be required to own, hold to control stock in the Corporation as a condition precedent to holding an office in the Corporation.



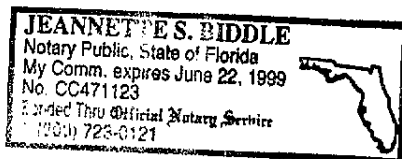

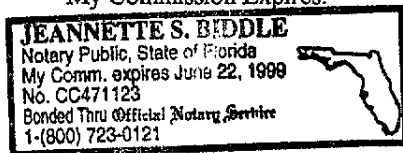
