# ARTICLES OF INCORPORATION OF FARIELLO RESTAURANT GROUP, INC.

#### ARTICLE I NAME

The name of this corporation shall be:

FARIELLO RESTAURANT GROUP, INC.

# ARTICLE II DURATION

This corporation shall commence its existence upon the filing of these Articles and the duration of this corporation is perpetual.

### ARTICLE III PURPOSE
