**ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION
CHANGING THE NAME OF SRA/IBM CORP.**

Pursuant to the provisions of Section 607.1006 of the Florida Statutes (the "Florida Business Corporation Act"), the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST - NAME

The corporation was incorporated on January 12, 1998 (document number 98000003213) under the name "SRA/IBM Corp." (hereinafter referred to as the "Corporation").

SECOND - AMENDMENT

Article I of the Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follow:

The name of this corporation shall be "SRA/Building 051 Corp."

THIRD - EFFECTIVE DATE OF AMENDMENT


The effective date of the amendment to the Articles of Incorporation of the Corporation set forth herein will be as of the date of filing of these Articles of Amendment to the Articles of Incorporation with the Secretary of State of Florida.

FOURTH

This amendment is made by the incorporator of the Corporation without shareholder action as the Corporation has not yet issued shares or actively begun to conduct business.
