**ARTICLES OF INCORPORATION
OF

The undersigned, for purposes of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I
NAME**

The name of the corporation shall be **CR SERVICES, INC.**

**ARTICLE II
DURATION**

The term of existence of the corporation is perpetual.

**ARTICLE III
PURPOSE**

The purposes of the corporation are:

- (a) To engage in the business of personal services.
- (b) To engage in and to transact any and all lawful business for which a corporation may be incorporated under the laws of the State of Florida.

**ARTICLE IV
CAPITAL STOCK**

The aggregate number of shares which the corporation has authority to issue is one thousand (1,000) shares, all of which shall be common shares with a par value of Ten dollars (\$10.00).

**ARTICLE V
REGISTERED OFFICE AND REGISTERED AGENT**

The street address of the initial registered office of the corporation is 1545 Sunset View Circle, Apopka, Florida 32703. The name of the initial registered agent at such address is Christine A. Repasky.

**ARTICLE VI
PRINCIPAL PLACE OF BUSINESS**

The initial place of business, and the mailing address, of the corporation shall be 1545 Sunset View Circle, Apopka, Florida 32703, until otherwise designated by the corporation.

ARTICLE VII DIRECTORS

The Board of Directors of the corporation shall consist of at least three directors and no more than five directors. The first members of the Board of Directors shall be elected at the organizational meeting of the shareholders of the corporation, and subsequent members of the Board shall be elected thereafter as provided in the by-laws of the corporation. The initial Board of Directors, for the purposes of these Articles of Incorporation, shall consist of three directors whose name and address are set forth below:

ARTICLE VIII OFFICERS

The corporation shall have such officers as may be provided in the bylaws of the corporation, and such officers shall be determined in the manner provided in the bylaws, and shall perform their duties during their respective terms of office as may be provided in the bylaws of the corporation.

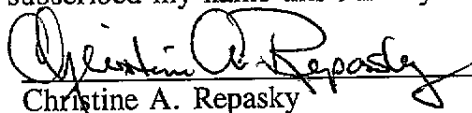

ARTICLE X AMENDMENTS TO ARTICLES OF INCORPORATION AND BYLAWS

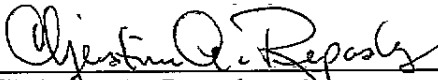
**DESIGNATION OF REGISTERED
