Articles of Incorporation of

OXFORD ACCEPTANCE COMPANY

The undersigned, acting as incorporator Oxford Acceptance Company a corporation to be formed under the provisions of the laws of the State of Florida, hereby adopts the following Articles of Incorporation for such corporation, to be filed with the Secretary of State of the State of Florida:

Article One

The name of the corporation shall be OXFORD ACCEPTANCE COMPANY. The principle place of business shall be 10715 S.W. 104th Street Miami, Florida 33176

ARTICLE TWO

The corporation shall have perpetual existence, unless sooner terminated according to law. The corporate existence shall commence immediately.

Article Three

The general purposes for which the corporation is organized are :

(a) To broker loans, leasing and financial lending sources for primarily commercial enterprises to lease or purchase equipment and accessories.

(b) To engage in any lawful activity, trade or business permitted under the laws of the United States of America and of the State of Florida.

Article Four

The aggregate number of shares of capital stock that the corporation shall have the authority to issue fifty thousand (50,000) shares with a par value of one cent (\$.01) per share.
