The undersigned, for the purpose of forming a corporation under Chapter 607, the Florida General Corporation Act, does hereby adopt the following articles of incorporation:

**ARTICLE ONE**

The name of the corporation is **COAST TO COAST FURNITURE SERVICE, INC.** and the corporate existence shall commence as of the date of the filing of these Articles of Incorporation.

**ARTICLE TWO**

The duration of the corporation is perpetual.

**ARTICLE THREE**

The general purpose for which the corporation is organized is to engage in the furniture repair business; and, to transact any other lawful business or businesses for which corporations may be incorporated under the laws of the State of Florida.

**ARTICLE FOUR**

The aggregate number of shares of stock which the corporation is authorized to issue is One Thousand (1,000). Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share. The consideration to be paid for each such share shall be fixed by the corporation.

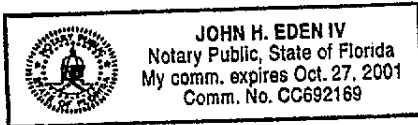
