ARTICLES OF INCORPORATION OF AMERICA BUILDING MAINTENANCE, INC. 98 JAN 13 AM 10: 53

THESE ARTICLES OF INCORPORATION are hereby adopted by the undersigned incorporator(s) of this corporation for pecuniary profit under the Florida Business Corporation Act.

ARTICLE I. NAME AND LOCATION OF AGENT AND OFFICES

EFFECTIVE DATE

SECTION 1.1 NAME:

The name of the corporation shall be AMERICA BUILDING MAINTENANCE, INC. SECTION 1.2 PRINCIPAL OFFICE or MAILING ADDRESS:

The principal office or mailing address of the corporation shall be 4835 48TH STREET WEST #501, BRADENTON, FL 34210. The corporation may change the forgoing addresses, transact business at other places within or without the State of Florida and establish branch offices within or without the State of Florida, all as the Board of Directors may from time to time determined.

ARTICLE III. PURPOSE AND POWERS

SECTION 3.1 PURPOSE:

SECTION 3.2 POWERS:

ARTICLE IV. AUTHORIZED SHARES

SECTION 4.1 CLASS, NUMBER, PAR and, DESCRIPTION:

The shares of stock authorized hereunder shall not be divided into classes and shall consist of one class of common stock only. The aggregate number of shares of stock which the corporation shall be authorized to issue and have outstanding at any one time shall be limited to Five Hundred(500) shares at One Dollar(\$1.00) par value.
