The Articles of Incorporation of Second Street Solutions, Inc., a Florida corporation, are hereby amended by deleting Article 4 in its entirety and substituting in its place the following:

4. Authorized Shares.

(a) Class A Common Stock.

(1) The Corporation is authorized to issue 10,000 shares of Class A common stock having a par value of \$.01 per share. No share shall be issued except upon payment to the Corporation of the par value of the share in cash or other consideration permitted by law as payment for shares.

(2) Each outstanding share of Class A common stock is entitled to one vote on each matter voted at a stockholders' meeting.

(3) Upon liquidation of the Corporation each holder of shares of Class A common stock shall have the right to a sum equal to a portion of the then fair market value of the Corporation equal to each share's relative portion of the par value of all Class A and Class B shares then outstanding.

(b) Class B Common Stock.

(1) The Corporation is authorized to issue 10,000 shares of Class B common stock having a par value of \$.01 per share. No share shall be issued except upon payment to the Corporation of the par value of the share in cash or other consideration permitted by law as payment for shares.

(2) The holders of shares of Class B common stock shall not be entitled to vote.

(3) Upon liquidation of the Corporation each holder of Class B common stock shall have the right to a sum equal to a portion of the then fair market value of the Corporation equal to each share's relative portion of the par value of all Class A and Class B shares then outstanding.

The foregoing amendment was adopted by the incorporator on October 28, 1998, without shareholder action. Shareholder action was not required.
