# ARTICLES OF INCORPORATION OF CFI MANAGEMENT, INC.

The undersigned incorporator, for the purpose of forming a corporation under the provisions of Chapter 607 of the reported Statutes, hereby adopts the following articles of incorporation.

#### ARTICLE I - NAME
