I must sincerely apologize for sending in our Uniform Business Report 2 weeks late this year. I am the secretary of our corporation, a family owned business, and I hope that you might be able to make a small exception for our late filing this year. Due to the recent illness and near death of our mother in California last month, both Scott Perry (the CEO and myself had to make last minute plane reservations to fly out to California on May 14th. Our mother is still in the hospital as of the date of this letter at Stanford Hospital in California. Also, if you might happen to have any other questions about this, please feel free to call me at 727-781-5101.

Our mother has had to have emergency surgery and nearly died. Both Scott and myself had thought that the deadline for filing was May 15th. When we got back and finally started trying to set things in order, we were completely surprised to find we had missed the deadline. I know you must certainly have a responsibility to enforce the guidelines of your department, but also, I would hope that you also might be able to exercise compassion in the way you enforce them. Please make an exception for us. We are a small company and a \$400 fine for us at this time, caused indirectly by our mother's nearly dying would be a serious difficulty for us.
