## ARTICLES OF INCORPORATION

OF

## ATLANTIC COAST FLEET SERVICE OF MEDLEY, INC.

The undersigned, being an individual, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

**FIRST:** The corporate name for the corporation (hereinafter called the "corporation") is ATLANTIC COAST FLEET SERVICE OF MEDLEY, INC.

**SECOND:** The address, wherever located, of the principal office of the corporation, if known, is 10052 N.W. 89<sup>th</sup> Avenue, Medley, Florida 33178.

<u>THIRD</u>: The mailing address, wherever located, of the corporation is 10052 N.W. 89<sup>th</sup> Avenue, Medley, Florida 33178.

<u>FOURTH</u>: The number of shares that the corporation is authorized to issue is two hundred, all of which are without par value and are of the same class and are to be Common shares.
