ARTICLES OF INCORPORATION

of

BAYONET POINT IMAGING CENTER, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby accepts all the rights, privileges, benefits and obligations conferred and imposed by said law on Corporations pursuant to the provisions thereof, and do hereby make, subscribe, certify and acknowledge and file these Articles of Incorporation.

ARTICLE I - CORPORATE NAME

The name of the corporation shall be: BAYONET POINT IMAGING CENTER, INC.

ARTICLE II - PERIOD OF EXISTENCE

The period during which the corporation shall continue is perpetual.

ARTICLE III - REGISTERED OFFICE AND AGENT

The address of the initial registered office of the Corporation is 13911 Lake Shore Blvd. - Unit L, Hudson, FL 34667 and the name of the initial registered agent therein and in charge thereof, upon whom process against the Corporation may be served, is Dr. Raj T. Rajan.

ARTICLE IV - PURPOSE

The purpose of the Corporation is to engage in any or all lawful business for which corporations may be organized under the provisions of the Florida Business Corporation Act.

ARTICLE V - SHARES

The total authorized capital stock of the Corporation is One Hundred (100) shares having a Par Value of NONE.
