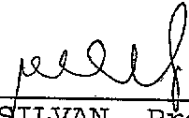
Article VIII

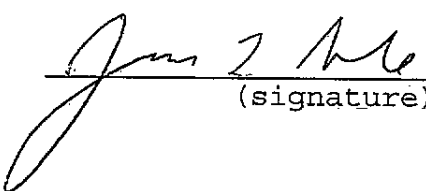
