ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION OF
CC MORTGAGE PROTECTION PLANS, INC.

Pursuant to provisions of the Florida General Corporation Act, the Undersigned Corporation adopts the following Articles of Amendment to the Articles of Incorporation.

1. The name of the corporation is **CC MORTGAGE PROTECTION PLANS, INC.**
2. The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on the 3rd day of April 2000, in the manner prescribed by the Florida General Corporation Act.

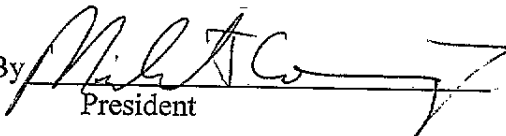
Effective immediately, the corporation shall change its name from:

The principal purposes are financial planning and insurance product sales. The Corporation may engage in any or all lawful business permitted to corporations under the laws of the STATE OF FLORIDA, or any other state, County, territory or nation.

3. The numbers of shares of the corporation outstanding at the time of adoption was Five Hundred (500) shares of common stock, and the number of shares entitled to vote thereon was also Five Hundred (500) shares of common stock.

4. The number of shares voted in favor of such amendment was Five Hundred (500) shares of common stock, and the number of shares voted against such amendment was none.

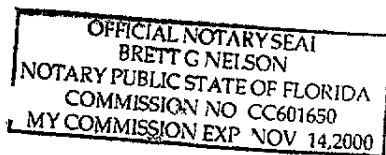
