ARTICLES OF INCORPORATION

OF

PAVEL REALTY CONSULTANTS, INC.



ARTICLE ONE

The name of this corporation is PAVEL REALTY CONSULTANTS, INC. and the mailing address of the corporation shall be 11514 Andy Rosse Lane, Captiva, FL 33924.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

ARTICLE THREE

The duration of the corporation is perpetual.


