The general nature of the business and objects and purposes proposed to be transacted and carried out on by this corporation are to do any and all of the things herein mentioned, as fully and to the same extent as natural people might do, viz: To engage in every aspect of import & export business as well as all kind of services related to this activity: and

- (2) Said corporation shall further have powers:
