The undersigned, acting as incorporators of a corporation pursuant to the Chapter 607 17/0//S

The undersigned Acting Articles of Incorporation for such corporation: Florida Statutes, adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE NAME

The name of the corporation is HOLLY L. DOIN, INC.

ARTICLE TWO CORPORATE DURATION

The duration of the corporation is perpetual unless dissolves according to law. Corporate existence shall commence at the time these Articles of Incorporation are filed by the Department of State.
