

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

The name of this corporation is Aïdan Media Specialists, Inc..

ARTICLE II.

The main location where the company shall conduct its business is 7134 Electra Drive South, Jacksonville, Florida 32210.

ARTICLE III.

The duration of the corporation shall be perpetual.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is one hundred (100) shares of common stock with a par value of Five Dollars (\$5.00) per share.


ARTICLE VII.

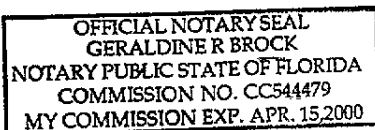
