## ARTICLES OF INCORPORATION OF

1900 THERAPY & REHABILITATION CENTER, INC.

The undersigned subscribers to these Articles of To To To Incorporation, desiring to form a corporation under the daws of the State of Florida, does hereby accept all of the rights and privileges, benefits and obligations conferred and imposed by said laws and does hereby adopt the following Articles of Incorporation as the Charter of the Corporation hereby organized.

#### ARTICLE I

#### NAME

The name of the Corporation shall be:
1900 Therapy & Rehabilitation Center, Inc.

#### ARTICLE II

#### DURATION

This Corporation shall have perpetual existence.

#### ARTICLE III

#### PURPOSES AND POWERS

This Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

The Corporation shall have all the powers set forth in the Florida General Corporation Law, as in effect from time to time, and including but not limited to the following powers:

a) To transact the business or any activity permitted under the laws of the United States and the State of Florida.

- b) To construct, erect, repair and remodel buildings and structures of all types for itself and others and to manufacture, purchase or otherwise acquire; and to own, mortgage, pledge, sell, or deal in and with, goods, wares, merchandise, personal property and services of every class, kind and description.
- c) To act as broker, agent or factor for any person, firm or corporation.
- d) To purchase, lease or otherwise acquire real and personal property and leaseholds thereof and interests therein, and to own, hold, manage, develop, improve, equip, maintain and operate, and to sell, convey, exchange, lease or otherwise encumber any and all such property and any and all legal and equitable rights thereunder and interests therein.
- e) To borrow or raise money for any of the purposes of the Corporation and from time to time without limit as to the amount to draw, make, accept, endorse, execute and issue promissory notes, drafts, bills or exchange, warrants, bonds debentures and other negotiable and nonnegotiable instruments and evidences of indebtedness, and to secure payment thereof and any interest therein by mortgage, pledge, creation of security interest, conveyance or other assignment in trust, in whole or in part, of the assets of the Corporation, real, personal or mixed, including contracts rights, whether at the time owned or thereafter acquired.

- f) To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of or any bonds, security, or other evidence of indebtedness created by any other corporation of the State of Florida or any other state or government, and while owner of such stock to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.
- g) To enter into, make perform and carry out contracts and arrangements of every sort and kind which may be necessary or convenient for the business of the corporation or business of a similar nature with any person, firm, corporation, association or syndicate or any private, public and municipal body existing under the government of the United States or any State, territory, colony or dependency thereof of foreign government so far as or to the extent that the same may be done or pursuant to law.
- h) To enter into or become a partner in any agreement for sharing profits, union of interests, cooperation, join venture or otherwise with any person, firm or corporation now carrying on or establish one or more offices, both within the State of Florida and in any part or parts of the world, at which meeting of directors may be held and all or any parts of the corporation's business may be conducted; and to exercise all or any of it's corporate powers territories, districts, dependencies, colonies or possessions in the United States of America and in any foreign countries.
