## ARTICLE I

The name of this corporation is CORONA RECORDS, INC.

ARTICLE II
[TERM OF EXISTENCE]

This corporation shall have perpetual existence.

### ARTICLE III

[NATURE OF BUSINESS & POWERS]

The general nature of the business to be transacted by this Corporation is to engage in any and all business, entertainment or otherwise, permitted under the laws of the State of Florida.

To organize, rehearse, coach, employ, represent, manage and develop artistic performing abilities of individuals who are performers, and to produce same for public and private performance in any foreign state or country of the world, in any entertainment medium whatsoever.
