PURSUANT TO SECTION 607.1006 OF THE FLORIDA BUSINESS CORPORATION ACT, THE UNDERSIGNED CORPORATION ADOPTS THESE ARTICLES OF AMENDMENT.

FIRST: THE NAME OF THE CORPORATION IS CAPITOL CITY RADIO PARTNERS, INC..

SECOND: THE ARTICLES OF INCORPORATION OF THIS CORPORATION ARE AMENDED BY CHANGING THE ARTICLE NUMBERED III SO THAT, AS AMENDED, SAID ARTICLE SHALL READ AS FOLLOWS:

THE NUMBER OF SHARES THE CORPORATION IS AUTHORIZED TO ISSUE IS SIXTY THOUSAND (60,000) TO BE DIVIDED INTO CLASSES OF 40,000 COMMON VOTING AND 20,000 COMMON NON-VOTING.


THIRD: THE AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE CORPORATION SET FORTH ABOVE WAS ADOPTED ON FEBRUARY 2, 1998.

FOURTH: PRIOR TO THE ISSUANCE OF SHARES, THE AMENDMENT WAS ADOPTED BY THE BOARD OF DIRECTORS WITHOUT SHAREHOLDER ACTION AND SHAREHOLDER ACTION WAS NOT REQUIRED.
