ARTICLES OF PROFESSIONAL ASSOCIATION

We, the undersigned, hereby associate for the purpose of becoming a Professional Association under Statute 621.0 of the laws of the State of Florida, and providing for the formation, liability, rights, privileges, and immunities of a Professional Association to conduct the business of a financial services, general public accounting, and tax matters practice.

ARTICLE I

The name of this Professional Association shall be RITSON & COMPANY, P.A..

ARTICLE II

The general nature of the business and the objects and purposes to be transacted and carried on are to do any and all things mentioned herein as fully and to the same extent as a natural person might or could, vis:

The primary purpose of this Proferssional Association shall be to conduct a financial services and general accounting practice within the State of Florida, which would include small business accounting services; individual and business financial and pension planning and management; and tax return preparation. In order to conduct such a professional services practice, it will also be empowered to:

- 1. Engage in every aspect and phase of business permitted under the laws of the United States of America.
- 2. Manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in, and with, goods, wares, merchandise, real and personal property, and services of every class and kind or description; except that it is not to conduct a banking, trust, insurance, surety, railroad, canal, telegraph, telephone or cemetary company, a building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, exposition or state fair.

- 3. Engage in any commercial or industrial enetrprise calculated or designed to be profitable to this professional association in conformity with the laws of the United States of America and of the State of Florida; to generally engage in, do, and perform, any enterprise, act, or vocation that a natural person might or could do; to engage in the production, manufacture, sale, purchase, importing and exporting of merchandise and personal property of all manner and description; to set up as agents for the purchase, sale, and the handling of goods, wares, and merchandise of any and all types and kinds, for the account of the association or as a factor, agent, procurer, or otherwise for or on behalf of another, to own, act as, or authorize distributors to further these ends.
- 4. Do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes, or for the attainment of any of the objectives, or for the furtherance of any of the powers, hereinbefore set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts incidental or appurtenant to or growing out of any part or parts thereof, provided the same be not inconsistent with the laws under which this professional association is organized.
- 5. Acquire, and pay for, in cash, stocks, or bonds of the association, or otherwise, the goodwill, rights, assets, and property, and to undertake or assume the whole or part of the liabilities of any person, firm, association, or corporation.
- 6. Borrow or lend money and to negotiate loans and issue bonds, debentures, notes and other evidences of indebtedness; and to secure the payment or performance of its obligations, by mortgage, deed of trust, pledge or otherwise.
- 7. Purchase, hold, sell, and transfer the shares of its own capital stock so far as may be permitted by the laws of the State of Florida.
- 8. Have one or more offices within or without the State of Florida; to carry on all or any of its operations and businesses without restriction or limit as to amount; to buy, hold, mortgage, sell, and convey such property as the purposes of the association shall require, where no special provision is made therefor by law or otherwise.
- 9. In general, to carry on any other business in connection with the foregoing, and to have and exercise all of the powers conferred by the State of Florida upon its domestic corporations.

The foregoing clauses shall be construed both as objects and powers,

and it is hereby expressly provided that the foregoing recitation of specific powers shall not be held to limit or restrict, in any manner, the powers of this Professional Association.

ARTICLE III

The amount of Capital Stock authorized shall be represented by ONE THOUSAND [1000] SHARES of Common Stock with no Par value.

ARTICLE IV

The amount of Capital with which this Corporation shall begin business is over ONE HUNDRED (\$100.00) DOLLARS.

ARTICLE V

This Professional Association shall have perpetual existence.

ARTICLE VI
