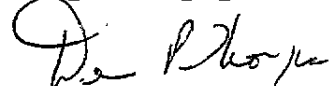

NAME

The name of this corporation shall be LANDMARK SALES & MARKETING, INC.

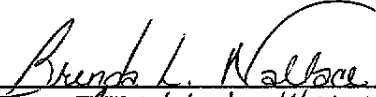

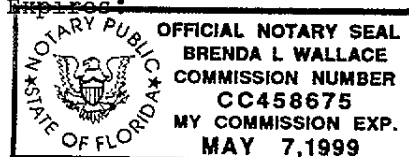
