ARTICLE I - NAME

The name of this Corporation is JSS OF ORLANDO, INC. and its address is 600 E. Colonial Drive, Suite 100, Orlando, FL 32803.

ARTICLE II - DURATION

This Corporation shall have perpetual existence.

ARTICLE III - PURPOSE

This Corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE IV - CAPITAL STOCK

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

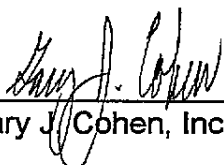
ARTICLE IX - INCORPORATOR

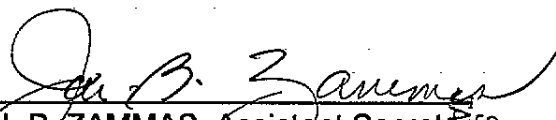
