ARTICLE I - NAME

The name of this corporation shall be DELAND AIRCRAFT LEASING, INC., and the address of the principal office of the corporation is 133 East Indiana Avenue, DeLand, Florida 32724.

ARTICLE II - DURATION

The term of existence of this corporation shall be perpetual.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of owning and leasing for hire a single engine airplane and conducting all activities reasonably necessary thereto.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 100 shares of common stock, each share with a par value of \$1.00.

ARTICLE V - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation will be 133 East Indiana Avenue, DeLand, Florida 32724, and the name of the initial registered agent at that office is George S. Smith, III.

ARTICLE VI - BOARD OF DIRECTORS

This corporation shall have five directors initially. The number of directors may be either increased or decreased from time to time by the By-laws. The initial directors shall be George S. Box 1587, Umatilla, Florida 32784; Charles Presley, 955 Flight Line Boulevard, DeLand, Florida 32724; and Charles L. Early, Jr., 112 North Florida Avenue, DeLand, Florida 32720.

ARTICLE VII - INCORPORATOR

The name and address of the incorporator of this corporation is George S. Smith, III, 133 East Indiana Avenue, DeLand, Florida 32724.


ARTICLE VIII - BY-LAWS

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors.

ARTICLE IX - AMENDMENT

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment to them, and any right conferred upon the shareholders is subject to this reservation.

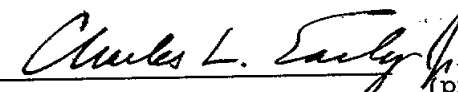
